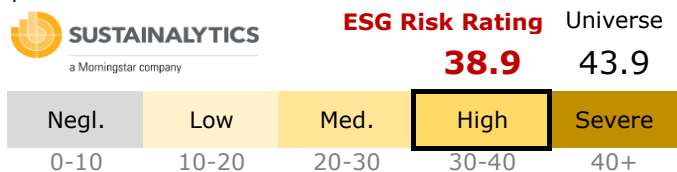
South Pole

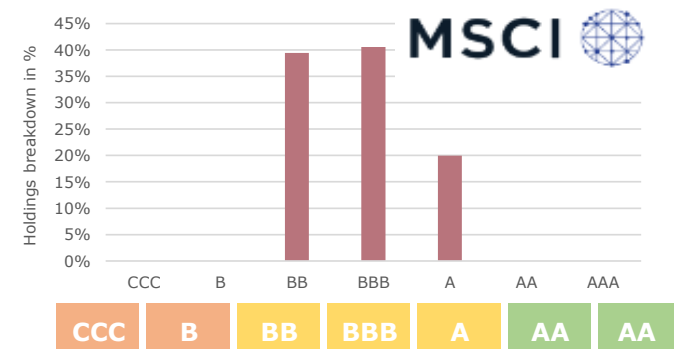
ECF Sustainalytics ESG Risk Rating

MSCI ESG Ratings range from leader (AAA, AA), average (A, BBB, BB) to laggard (B, CCC).
